4. SCNCA Championships - proposal to host the Junior Criterium Championships with the Master's Championship (CB). Ken Vinson wants to do juniors SCNCA district championships at ElDo (Chris B received application today) – approved – none opposed – deadline has passed so first application received gets it.
5. BOD Election Report (DH) – 5 nominees; election to proceed with them - board voted against extending nomination deadline briefly to allow several late nominations and potentially any others to be considered. Board recognized that relatively high percentage of late applicants may suggest need for improvements in the nomination/election process. Considered improvements include: developing better means to communicate directly with individual stakeholders to avoid information bottleneck at club level, announcing nomination/election process with more lead time, and lengthening nomination period.
6. Rider Feedback Survey w/NCNCA cost \$234 (basecamp) – approved – Sean (via Melissa) will organize to pay our share
7. Proposal for SCNCA to fund prize list for 3-day Memorial Day omnium in 2026 (basecamp) – challenge is LAX Circuit Race can't move dates so likely a moot proposal. Idea shelved for now
8. Report from Development Committee (Sean / Max) – suggestion of involvement with VeloYouth in SD; SDVA, LABC, orgs with events already happening, goal of getting rider count up in general
9. Sean moved, Max seconded, adjourned at 8:24 PM
