4. California State Championships Budget Request (NCNCA-SCNCA Unified Championships Committee):
Approved (in Basecamp): \$1,343.65 for 50% share (NCNCA paying other 50%) of commemorative podium prize socks by SockGuy
 5. Communications Committee Oversight Proposal (Communications Committee) -
Approved (in Basecamp): To grant the communication committee broad oversight and authority over the SCNCA's various communication channels for the purpose of unifying messaging and creating continuity across all channels of communication. This would include the newsletter, social media accounts, any print content, and the SCNCA website. Messaging through these platforms would pass through the communications committee.
 6. Annual Stipend to Social Media Manager Proposal (Communications Committee) -
Approved (in BaseCamp): to pay Julie S. as a contractor to continue providing our social media content via Instagram and Facebook, as she has done previously as a director, with the payment amount set at \$500 annually.
 7. Proposal to Expand Newsletter Distribution During “Busy” Months (Communications Committee) -
Approved (in Basecamp): to increase newsletter distribution to twice monthly during the busiest part of the racing season (approx March-June), continuing to pay Melissa A. hourly as we have been for her services.
